## **Executive Summary**

At SaltExchange, our mission is to ignite and empower lasting change across the world. We believe in the power of unity and collective action to transform lives. SaltExchange firmly upholds the view that the commercial sexual exploitation of children (CSEC) stands as an unconscionable crime, one that demands not only zero tolerance but also an unwavering and resolute response. This crisis, of a vast and intricate nature, extends worldwide and is characterized by its harrowing implications. While the efforts of individual nonprofit organizations and philanthropists responding to this overwhelming

cruelty are of utmost importance, they frequently operate in isolated silos, leading to duplication and diminished efficiency. It is the over 1.7 million children across the globe, subjected to sexual exploitation for financial gain each year, who bear the brunt of these fractured, broken systems.

In collaboration with Faith Driven Investor, SaltExchange introduced its inaugural Philanthropic Brief in January 2023 defining the issue of CSEC and offering estimations of its prevalence around the world. The brief outlines a strategic approach focusing on both the "supply" and "demand" sides of the problem to achieve sustainable change.

Diving deeper into Collective Action, The Dignity of Children Preliminary Report expands on the strategic approach summarized in the philanthropic brief. Without endorsing specific organizations, the report equips potential givers with insights into the diverse stakeholders engaged in prevention, intervention, survivor rehabilitation, and systemic change. Furthermore, the report encapsulates SaltExchange's collective action aspiration to safeguard and restore the dignity of every child.





## **Prevention**

Prevention efforts are focused on thwarting instances of CSEC before they occur. This work constitutes an "upstream" approach within the broader endeavor to combat this horrendous issue by directly tackling its origins. These preventive measures encompass various strategies targeting both potential victims and potential perpetrators of CSEC. These initiatives range from addressing vulnerabilities tied to socioeconomic challenges to educating at-risk children, such as those who are

homeless or aging out of the foster care system, about identifying and responding to warning signs. Additionally, prevention efforts utilize online platforms to expose or deter potential buyers and sellers of CSEC, ultimately aiming to disrupt the occurrence of these transactions.

#### ANTI-CSEC INTERVENTIONS AND ENDORSEMENTS

## Rescue

Rescue operations aim to intervene in instances of CSEC. At a basic level, this requires removing victims from dangerous situations and apprehending buyers and sellers. Identification of victims, buyers, and sellers is pivotal, and certain interventions focus on providing resources to law enforcement and relevant entities to effectively recognize and respond to CSEC indicators. In cases of online CSEC involving Child Sexual Abuse Material, rescue entails eliminating such content and liberating children

while arresting perpetrators from the circumstances in which the content originated. Subsequent steps involve prosecuting apprehended buyers and sellers and, where legal systems need to be strengthened, supplying law enforcement with the resources and personnel they need to make sure that perpetrators are brought to justice.

Survivors of CSEC endure profound trauma, and in response, comprehensive rehabilitation initiatives are in place to guide them through the intricate process of healing. This multifaceted endeavor encompasses a spectrum of essential components, ranging from addressing immediate requirements such as secure housing upon rescue, to ensuring access to vital mental health counseling services. Moreover, rehabilitation extends to encompass the provision of workforce development and job placement programs, crucial for empowering

survivors to embark on a new life trajectory. Some survivors desire to channel their experiences into advocacy against CSEC, and numerous organizations are intentionally structured to empower and inspire survivor-driven change, amplifying their voices for meaningful reform.

## **Collective Action Overview**

Collective action is an approach that advances and unlocks efficiencies in philanthropy and population level impact by incentivizing collaboration between nonprofits that have mutually reinforcing programs.

The concept of collective action and its core principles were articulated in a 2011 article published by the Stanford Social Innovation Review (SSIR). Drawing on the example of the US public education system, the SSIR highlighted that despite the dedicated efforts of teachers, administrators, nonprofits, and billions in charitable funding, achieving "system-wide progress has seemed virtually unobtainable" due to fragmented, individualized approaches. Contrasting this, the Strive organization led communities in Cincinnati and northern Kentucky to adopt a collective

approach, eventually bucking national trends and achieving remarkable indications of success in their public schools. According to the SSIR, these accomplishments couldn't have been realized by a single entity, no matter how innovative or influential. Years later, in the article <u>StriveTogether:</u> Taking a Place-Based Network to National Scale, the Rockefeller Foundation reviewed the effort and stated, "These gains were achieved through a cross-sectoral network of partners that addressed turf issues among the community's educational service providers and encouraged funders to support strategies with the strongest track record." While covering different focus areas, initiatives such as <u>illumiNations</u>, the <u>Fund for Our Economic</u> Future, and SAFE in Washington have used the collective action adaptive approach as well to drive collaboration towards successful outcomes.


Collective action functions as an emergent strategy that focuses on strengthening networks and dismantling silos through sustained communication among like-minded organizations and progress assessment. To achieve success, the collaborative endeavor will prioritize the development of five fundamental components, as explained by the Collective Impact Forum:

- · A unified agenda
- · Shared measurement
- · Activities that mutually reinforce
- Continual communication
- An independent, backbone team

This collective effort needs to incorporate two distinct forms of leadership: galvanizing leadership and collective leadership. As described in the *Collaboration Handbook*, written by Chris Thompson and published by the Fund for Our Economic Future, the galvanizing leadership convenes funders and practitioners to unite around a common cause that is bigger than any one organization. The collective leadership involves the ongoing management of the collective action efforts.

The time has come, and perhaps even long overdue, to transition from the traditional nonprofit model of individual funding and solutions, towards a collective action framework. If stakeholders utilize this collaborative approach, the work holds the potential to significantly enhance the well-being of those philanthropists aspire to serve. SaltExchange firmly believes that collective action is imperative for addressing intricate systems such as CSEC; in other words, combating CSEC demands an ongoing collaborative effort and, as stated in the Collaboration Handbook, a capacity to adapt to the "dynamic and evolving inter-relationships among a diverse set of stakeholders in a rapidly changing environment."

If stakeholders utilize this collaborative approach, the work holds the potential to significantly enhance the well-being of those philanthropists aspire to serve.



## The SaltExchange Initiative

SaltExchange exists to empower impact through collective action. To realize this mission, the SaltExchange organization is structured into three interconnected divisions:



Philanthropic Network – Facilitates peer learning communities for philanthropists and develops collective action funds, connections, and expertise to create systemic impact



**Collective Action Projects –** Provides opportunities for philanthropists to strategically collaborate with nonprofits and empowers nonprofits to work together to drive impact



SaltExchange is poised to leverage these three dynamic aspects of its organization to catalyze a profound shift in philanthropic impact, beginning with anti-CSEC efforts and then expanding. Firstly, its Philanthropic Network, which has been built over years by SaltExchange's Founder & CEO, Johanna Sheridan, and team members, will act as a hub for fostering learning communities among philanthropists, cultivating a collaborative space for the exchange of insights, strategies, and best practices. By nurturing collective action funds, connections, and expertise, this network will steer resources toward transformational changes that reverberate far beyond individual initiatives.

Secondly, under the umbrella of its Collective Action Projects, SaltExchange has launched the Dignity of



Children Pilot Project focused on anti-CSEC efforts. Leveraging its Philanthropic Network, SaltExchange is forming a galvanizing leadership team for the project, which as previously stated, is a powerful force for uniting funders and practitioners around a common cause. 



Thirdly, SaltExchange is developing an innovative Impact Technology Platform that will serve as a linchpin, orchestrating seamless coordination between philanthropists and nonprofits. This platform will not only streamline collaboration but also embed feedback loops within the process, ensuring constant improvement, alignment, and investment among all stakeholders.



## SaltExchange Goals

In summary, SaltExchange's goals include:

- 1 Harnessing the power of a reliable network of trusted stakeholders engaging in collective action to enhance and fortify the entire continuum of care, spanning from preventative measures to restorative care and rehabilitation.
- **Demonstrating the power of collective action** rooted in principles of systems
  thinking, meaningful collaboration, and
  abundant generosity through baseline
  prevalence studies and program evaluations.
- Piloting a project with community stakeholders focused on one of the four intervention points prevention, rescue, rehabilitation, ecosystem capacity building that will strengthen areas of the system

that need the most work and resources to succeed. Long-term, this will result in measurable reductions in the number of children who are sexually exploited and/or an increase in the number of survivors who have their lives restored.

Developing a scalable technology platform that will support communication and coordination between philanthropists and nonprofits in its network.

This effort aims to catalyze and provide proper infrastructure for collective action to reduce the prevalence of CSEC globally.
